DIRECTIONS FOR USE: (8 ounces=1 cup)

Recommended treatment is through Chemigation (drip, trickle or microjet irrigation), Foliar Spray or Drench. A stock tank may be used to dose product. Partially fill the mix tank with clean water. Add the specified amount of **N-Terragate RD** to the tank. Finish filling the tank with clean water to the necessary volume. The solution should be agitated during mixing and application to assure uni-form suspension. **N-Terragate RD** can be mixed and used with other agricultural chemicals, for which such mixing is permitted by the product label. If such a mixture is planned, a compatibility test should be first conducted. Avoid mixing with quaternary com-pounds, Peroxyacetic Acid (PAA), or similar type broad spectrum biocides. Do not allow mixture to stand overnight or for prolonged periods. Mix well before each use. Dose 5 LBs per acre. For specific dosage rates and frequency of treatment, contact your Account Representative.
