DIRECTIONS FOR USE: (8 ounces=1 cup)

Recommended treatment is through Chemigation (drip, trickle or microjet irrigation), or Drench. A stock tank may be used to dose product. Partially fill the mix tank with clean water. Add the specified amount of N-Terragate RH P-100 to the tank. Finish filling the tank with clean water to the necessary volume. The solution should be agitated during mixing and application to assure uniform suspension. N-Terragate RH-P 100 can be mixed and used with other agricultural chemicals, for which such mixing is permitted by the product label. If such a mixture is planned, a compatibility test should be first conducted. Avoid mixing with quaternary compounds, Peroxyacetic Acid (PAA), or similar type broad spectrum biocides. Do not allow mixture to stand overnight or for prolonged periods. Mix well before each use. Contact your Account Representative.
